Mugwort takes the job seriously and often drives by employee homes to document how they're spending money. 

Nobody knows where Keisha gets the money to buy such luxurious items. How much could a senior risk officer get paid, anyway? **For the expandable teams, you'll have a separate file to download for each team. Make as many copies as you'll have players on the team (they are duplicate roles). Here is our FAQ on expandable teams:**

**Expandable Teams:** Some games may have expandable players. This is denoted in the description, the product details and the character list. This means a specified player(s) is designed to have an optional team with them during the game. It's as if you were invited to a party and decided to bring along your friends/colleagues. What would you speak to the other guests about if you attended a party with your friend? You'd have the mutual acquaintance in common, so that's what you'd talk about! In other words, if the character is a magician, they can have a team of up to ~15-20 magician's assistants with them. The assistants' cards will have the information/clues of their lead player and that is what they use to play with in the game. The expandable players all have duplicate cards, but are in the game just like everybody else otherwise. This is a great way to host large events and still give everyone a role in the game. If you are hosting a party for a large group, you would not want 50+ story lines to sift through once the mystery occurs. That can be a nightmare if the game isn't designed to be a large group from the start. Expandable teams enable you to grow your guest list without adding chaos to your game – while still giving extra players a role in the game.

Bottom line: with a large group, not everyone can have a unique character if you want your game to be fun and not chaotic.

# Host Instructions

**FULL HOST INSTRUCTIONS WILL BE INCLUDED IN THE PURCHASED GAME. THE INSTRUCTIONS ARE DETAILED, YET BRIEF AND EASY TO FOLLOW.**

**ALSO, THE GRAPHICS IN THIS SAMPLE GAME ARE THOSE OF THE INSTANT DOWNLOAD VERSION. THE BOXED KIT HAS DOUBLE-SIDED, FOLDED CLUE CARDS WITH THE TRADITIONAL MYSTERY THEME ON PARCHMENT-STYLE PAPER.**

**GAME STRUCTURE:** the game is organized into four rounds and is structured as follows:

**OPTIONAL PRE-GAME STARTER:** these optional pre-game tasks are to be delivered to each guest before the party, or give them to the guests as they arrive. All pre-game materials are optional. They are intended to enhance the build up for the event. These tasks are not vital to solving the mystery. Also, encourage your guests to view the Your Mystery Party guest pre-game website to get them excited about your game (this is highly-encouraged).

**ROUND ONE:** Deliver the round one clue card envelopes as your guests arrive. It is optional to serve cocktails for adults and appetizers.

**ROUND TWO:** Deliver the round two clue card envelopes. It is optional to break for dinner either before or after this round.

**SOLUTION ROUND THREE:** Deliver the round three solutions. It is optional to serve coffee/hot cocoa and dessert.

Don't host a party without some type of food/beverage offering - hungry guests are not happy guests.

# Example Timeline

**7:00 PM:** Guests arrive. Take guest photos and serve refreshments. Have the invited guest list available for the guests to view as they trickle into the party. Once everybody has arrived, snap a group photo!

**7:10 PM:** The host goes over the guest instructions for the mystery game. It is optional to have each character stand up and introduce themselves to the group. You can play the game trailer video for an introduction.

**7:20 PM:** The round one clue cards are handed out, and the game begins. The guests mingle and discuss the clues on their clue cards. Motives will start to unfold during this round.

**7:50 PM:** An optional bonus game is played.

**8:05 PM:** An optional dinner is served. Snacks can be served throughout the party instead.

**8:35 PM:** The ransom note appears and the players discuss the note.

**8:45 PM:** The round two envelopes are handed out, and the guests mingle about with their pre-murder clues.

**9:00 PM:** The victim is revealed, and the investigation of the crime begins. The mystery investigation sheets are handed out, and the guests interrogate each other (using the post-murder clues). Each guest should interview every player in the game.

**9:15 PM:** The forensic report is revealed.

**9:30 PM:** The investigation sheets (guesses of whodunit) are turned in to the host. After the sheets are collected, the guests may take turns accusing who they believe did it.

**9:45 PM:** Dessert and coffee may be served at this time. The round three solutions are handed out to the guests. Each player presents their solution, and the murderer confesses at the end. Allow a few minutes for the guests to mingle at the end to discuss the mystery.

**10:00 PM:** Another optional bonus game may be played &/or host an optional awards ceremony!

To shorten the mystery party, omit the bonus games, don't stop for dinner, omit the accusation round, and don't host an awards ceremony. Also, you can shorten the game even further by only having the required players read their solutions (or even just the murderer). If you wish to extend the length of the party, add more bonus games!

Note: if you are playing this with the expanded teams, you'll need to add more of a time cushion to deal with that many people. Also, don't encourage everyone to speak to every other player each round, as there won't be time for 100+ people to mingle 100+ times each round. As the host, you'll need to push the game along on your scheduled time frame. We suggested having at least a team of 2-3 people in charge of hosting large events – it's too much for one person to handle solo.

## **OPTIONAL PRE-GAME TASKS:**

### **Character A**

**OPTIONAL:** for pre-party fun, contact the following guests before the party:

Contact the guest playing **Character Y** and say you'd like to arrange a meeting the first of next week to discuss your *issues*. You'll talk after the conference in New York.

**CONTACT INFO:**

Contact the guest playing **Character K** and say he was upset over not being appointed as the interim CEO in Eric Wilde's absence. However, the job requires an MBA according to the corporate bylaws.

**CONTACT INFO:**

Contact the guest playing **Character C** and say you overheard her discussing an issue she was having with a fellow employee. You didn't mean to eavesdrop, but issues like that should be handled through Human Resources. It's best not to allow problems to fester.

# ROUND ONE CLUES

## CHARACTER H – ROUND ONE

### CLUES TO REVEAL DURING THIS ROUND

#### Discuss the following information:

- 📌 You admit to bashing Character D in the employee breakroom the other day. You didn't realize there was anyone else in the room besides your close friend, Character R. You feel bad for being a mean person, but you and Character D are opposites and never see eye to eye on anything. You'd just had a debate about her sending unqualified applicants to your department. It seems s/he does this to people in the company s/he doesn't like to waste their time.
- 📌 Ask around to see what others think happened to the missing CEO (Eric Wilde). You find it very strange that his car keys and his wallet were in his top drawer. That screams 'foul play' to you.

#### PERSONAL CLUES TO CONCEAL

- 📌 You are a nice person, but you have limits. You've had enough of Character N. You'd love to get her fired, but don't know how. Be nice to everyone during the party and avoid Character N.
- 📌 You also do not trust Character B. You think s/he has an ulterior motive. Anyone who lurks around the hallways at work doesn't have the company's best interests on their mind.

## ROUND 2 CLUES

### CHARACTER Y - ROUND TWO

#### Pre-Murder Clues

-  You're still watching Character W, Character K, and Character B, but haven't been able to determine which one is the spy. The quicker you can solve the case, the quicker you can go home.
-  Ask Character G about her 'performance plan.'
-  Ask Character M if it is true that s/he is related to someone in the company.
-  Speak to Character S about the open position in the subdivision of the Director of Retail Finance and Restructuring. *(If you work for Character S, it might be easier to investigate – and it gives you something to talk about at the conference, at least.)*

#### Post-Murder Evidence & Alibi (Blood Type O-)

- You left the South Oak Ballroom ~15 minutes before the victim left the ballroom. You were gone for ~3 minutes. You grabbed a quick bite to eat from the dining room across the hallway.

DIAGRAM OF THE BALLROOM WING OF THE HOTEL




